A RESOLUTION ADOPTING A SUPPLEMENTAL BUDGET FOR FY 2021-2022

WHEREAS, an allocation error occurred of placing seismic grant monies within the General Fund under miscellaneous income and set for a transfer-out to the Building Reserve Fund. The District wishes to correct the placement error by creating a separate reserve fund, titled 'Seismic Grant Reserve Fund' and place the seismic grant program monies the District is set to receive in Fiscal Year 2021-22 in this new fund; and

WHEREAS, the District held a public hearing on March 15, 2022 to review the supplemental budget adjustments and the establishment of the new reserve fund; and

WHEREAS, the District wishes to correct the misplaced \$2,092,758 seismic grant revenue and place it into the newly established Seismic Grant Reserve Fund. The separate allocation will allow complete accountability of revenue and expenses to the State of Oregon and clarity to the public. This will be accomplished by the following appropriations and budget adjustments:
